



Release of Liability, Waiver of Claims, and Assumption of Risks

**BY SIGNING THIS DOCUMENT, YOU WILL WAIVE CERTAIN LEGAL RIGHTS,
INCLUDING THE RIGHT TO SUE OR CLAIM COMPENSATION**

PLEASE READ CAREFULLY!

In consideration of Maynstream Transport Inc., an Ontario Corporation (the "**Company**"), transporting the individual named below ("**I**" or "**me**") and any guests of mine in busses and/or cars owned by the Company (the "**Vehicles**") to various locations (the "**Activities**"), and for other good and valuable consideration, I agree to all the terms and conditions set forth in this agreement (this "**Agreement**").

ASSUMPTION OF RISKS

I AM AWARE AND UNDERSTAND THAT THE ACTIVITIES INVOLVE MANY RISKS, DANGERS, AND HAZARDS, INCLUDING BUT NOT LIMITED TO THE RISK OF SERIOUS INJURY, DEATH, OR PROPERTY DAMAGE. I ACKNOWLEDGE THAT I AM VOLUNTARILY PARTICIPATING IN THE ACTIVITIES. I FREELY ACCEPT AND FULLY ASSUME ANY AND ALL OF THE RISKS, DANGERS, AND HAZARDS INVOLVED AND THE POSSIBILITY OF INJURY, DEATH, OR PROPERTY DAMAGE, WHETHER CAUSED BY THE NEGLIGENCE OF THE COMPANY OR OTHERWISE.

I am aware that the Vehicle may need to stop suddenly and/or without warning. Riding without a seatbelt, standing, and walking in a moving vehicle is inherently dangerous. I understand that the floor and steps in the Vehicle may be slippery. I agree to participate in the Activities despite the foregoing.

I or my guests will not smoke, vape, or consume illegal drugs in the Vehicles.

I acknowledge that I or my guests are not allowed to drink alcohol in the Vehicles or have open containers of alcohol in the Vehicles. I acknowledge that all laws and regulations regarding alcohol, cannabis, and nicotine must be followed by the passengers participating in the Activities.

If I or my guests are found to be in violation of any laws or regulations regarding the consumption or possession alcohol, cannabis, or nicotine, I will bear the full legal and financial responsibility for any consequences arising therefrom, including but not limited to fines, citations, legal actions, or claims. I shall hold harmless and indemnify the Company and their employees or agents from any and all liability, claims, demands, or actions that may result from the possession or consumption of the above listed substances.

Any inappropriate behaviour will result in the offending passenger(s) being asked to disembark immediately. No refund will be issued to passenger(s) asked to disembark for inappropriate behaviour. Inappropriate behaviour includes, but is not limited to, extreme intoxication, giving alcohol to others, inappropriate language or gestures, public urination or vomiting, violence or threats of violence, and/or any other behaviour determined to be inappropriate by the Company's agents or drivers. The Company's agents or drivers shall retain the right to terminate the Activities at any time due to the behaviour of the me, my guests, or my fellow passengers.

Any decisions made by the Company's agents or drivers based on their judgement shall be final.

I hereby expressly waive and release any and all claims which I have or may in the future have against the Company, its affiliates, and their respective directors, officers, employees, agents, representatives, shareholders, successors, and assigns (collectively, "**Releasees**"), arising out of or attributable to the Activities, due to any cause whatsoever, including without limitation the negligence of the Company or any other Releasee, breach of contract, or breach of any statutory or other duty of care owing under occupiers liability legislation or otherwise. I covenant not to make or bring any such claim against the Company or any other Releasee, and forever release and discharge the Company and all other Releasees from liability under such claims.

I SHALL DEFEND, INDEMNIFY AND HOLD HARMLESS THE COMPANY AND ALL OTHER RELEASEES AGAINST ANY AND ALL LOSSES, DAMAGES, LIABILITIES, DEFICIENCIES, CLAIMS, ACTIONS, JUDGMENTS, SETTLEMENTS, INTEREST, AWARDS, PENALTIES, FINES, COSTS, OR EXPENSES OF WHATEVER KIND, INCLUDING REASONABLE LEGAL FEES, IN CONNECTION WITH ANY THIRD-PARTY CLAIM, SUIT, ACTION, OR PROCEEDING ARISING OUT OF OR RESULTING FROM THE ACTIVITIES.

I AGREE TO BEAR RESPONSIBILITY FOR THE ACTIONS AND BEHAVIOURS OF ANY GUESTS THAT TAKE PART IN THE ACTIVITIES. I UNDERSTAND THAT I AM RESPONSIBLE FOR ANY DAMAGE CAUSED BY MY GUEST(S) TO COMPANY PROPERTY. I SHALL REIMBURSE THE COMPANY FOR ANY DAMAGE CAUSED BY MYSELF OR MY GUESTS.

This Agreement constitutes the entire agreement of the Company and me with respect to the subject matter contained herein and supersedes all prior and contemporaneous understandings, agreements, representations, and warranties, both written and oral, with respect to such subject

matter. If any term or provision of this Agreement is held to be invalid, illegal, or unenforceable in any jurisdiction, such invalidity, illegality, or unenforceability shall not affect any other term or provision of this Agreement or invalidate or render unenforceable such term or provision in any other jurisdiction. This Agreement is binding on and shall enure to the benefit of me and my heirs and next-of-kin, and the Company and its successors and assigns. This Agreement shall be governed by and construed in accordance with the laws of the Province of Ontario and the federal laws of Canada applicable therein. Any claim or cause of action arising under this Agreement may be brought only in the courts of the Province of Ontario, and I hereby consent to the exclusive jurisdiction of such courts.

I ACKNOWLEDGE THAT I HAVE READ AND UNDERSTOOD ALL OF THE TERMS OF THIS AGREEMENT AND THAT I AM VOLUNTARILY WAIVING SUBSTANTIAL LEGAL RIGHTS (ON MY BEHALF AND ON BEHALF OF MY HEIRS, EXECUTORS, ADMINISTRATORS, AND NEXT-OF-KIN), INCLUDING THE RIGHT TO SUE THE COMPANY AND THE RELEASEES.
